Tuition/Payment Agreement

Due August 1

I agree as a member in good standing of the New World Youth Orchestras, to attend the weekly rehearsals and concerts. If I must miss a rehearsal, I agree to notify the organization as outlined on the website and in the Student Handbook. Because of the necessity of having all members present on a regular basis to accomplish our musical goals, I understand that if I miss more than **two unexcused rehearsals** per concert cycle, **or am consistently tardy**, I may be asked to relinquish my membership in the New World Youth Orchestras.

New World Youth Orchestras recognizes that financial circumstances vary for every family. Therefore we offer 3 payment options from which you may choose. **Note: All options include the retreat fee (as this is a required event) in their totals.** If your conductor allows an absence for that date, you will not be responsible for the retreat fee (\$30 for Philharmonic and Symphony and \$15 for Concert Orchestra).

Note: Confirmation of your initial payment and plan selected will be mailed upon receipt of the initial paperwork. Statements will be mailed during the season, though the schedules will also be posted on the website.

LATE FEE – NEW!!

Applicants accepted in July – One of the above plans must be established by August 15 or a \$30 late fee will be assessed regardless of the plan selected. The fee will also be waived if a financial aid form is submitted by August 15.

Applicants Accepted On or After August 1

Applicants notified of acceptance in August or September - A one-month grace period will be given for full payment or deposit (no late fee assessed until one month after the member has joined). Payment plans will have the same due dates as those noted above with dollar amounts adjusted as necessary.

Applicants who begin rehearsing with New World following any of our season concerts – Your tuition will be prorated accordingly and no late fee will be assessed. For example, Concert Orchestra performs 4 concerts during the season and annual tuition is \$250. A member joining after the first concert in October will have their tuition decreased by one-quarter to \$187.50.
